TFR to Affect NBAA Convention

If you're heading to Orlando next week – a “VIP” movement is anticipated to take place in Orlando on Monday, October 29. It is expected to result in a Temporary Flight Restriction (TFR), which will impact some number of aircraft arrivals and departures in Orlando for NBAA's Convention, which starts on Tuesday, October 30. Although the exact timing for the TFR is not yet confirmed, NBAA reports that its duration is anticipated to be relatively brief. NBAA is working with the FAA and government security officials to establish this and other information, and also to mitigate, to the greatest extent possible, the impact on business aviation operations on that day.

Regional News Round-Up



A groundbreaking ceremony was held for the new terminal at **Stafford Regional Airport**. The \$3.4 million, 10,000-square foot building is expected to be completed in August 2013. Airport authority chairman Henry Scharpenberg told the *Stafford County Sun* that the terminal's construction is “an important step in increasing the facility's visibility as an economic engine.” Other upcoming projects at the airport include the removal of obstructions that prevent the use of an ILS landing system and the extension of the runway.

ProJet Aviation at the start of the month became the operator of the FBO at **Leesburg Executive Airport**. Landmark Aviation previously announced that it intended to sell the operation to ProJet, and the transaction was approved by the town council in September. The FBO had operated under the Landmark brand since 2005; the current lease runs through 2016.

Salisbury-Ocean City/Wicomico Regional Airport has begun a \$1.8 million terminal renovation project, and is also planning to start work this month on FAA-funded runway improvements.

Associated Aircraft Group, which operates Sikorsky S-76 helicopters, has announced that it has been approved to operate flights to **Reagan National Airport** under the DCA Access Security Program (DASSP).

On September 29, the pilot and passenger aboard a Cessna 150 were killed when it crashed shortly after takeoff from **Shannon Airport** in Fredericksburg. As always, fly safely!
