## Loudoun County Aircraft Tax Increase Avoided

### Board of Supervisors Rejects Proposal to Increase Taxes by up to 4000%

The Loudoun County Board of Supervisors on January 20 rejected a proposal to increase its property tax on aircraft, which is currently one cent per \$100 of assessed value. The finance committee of the board had suggested a new rate of up to 40 cents - a 4000% increase. The Town of Leesburg, in which Leesburg Executive Airport is located, previously has opposed efforts to raise the tax, and continued its opposition in this case, with support from the aviation community, including GWBAA. Before the Supervisors meeting, Leesburg Airport Commission Chair Dennis Boykin told *Leesburg Today* that “[a]ny increase above the current level will chase aircraft away and create a net loss of revenue to the county.”

At the meeting, industry representatives alerted the board to numerous flaws in its proposal – including that five nearby airports in Virginia have tax rates well below \$0.01, and additional nearby airports in Maryland and West Virginia that have no taxes at all. FBOs at Washington Dulles Airport (also in Loudoun County) further argued that a tax increase would negatively affect their business; FBOs employ hundreds of people that support and service aircraft have been forced to reduce their staff. Based on the wide-ranging negative feedback, Loudoun County unanimously decided not to increase the tax. GWBAA President Paige Kroner stated that “while this is a victory for the business aviation community, it is an important reminder that we cannot be complacent, and must remain vigilant against threats to our ability to conduct business in the greater Washington area.”

### FAA General Aviation News

### Regional News Round-Up

James Bennett (President of the Metropolitan Washington Airports Authority) recently stated that he was eager to see post-9/11 restrictions on general aviation flights at **Ronald Reagan**

**Washington National Airport** eased. The *Sun-Gazette* reports that his remarks at a January 19 forum hosted by the Metropolitan Washington Council of Governments included that general aviation is "a very important part of our aviation infrastructure capacity at Reagan National - we'd certainly like to see that returned." Pre-9/11, DCA accommodated about 10 to 12 general-aviation flights per hour, but now handles just one or two per day, Bennett said. Carmine Gallo, administrator of the FAA's Eastern Region, added that aviation officials are holding an "ongoing, aggressive discussion" about general aviation's access to Reagan National.
